

# 1. UNESCO

#### 1.1. Introduction

The United Nations Educational, Scientific and Cultural Organization (UNESCO) was founded on 16<sup>th</sup> November 1945 and is headquartered in Paris, France. The Preamble of the UNESCO Constitution establishes UNESCO as an organisation committed to the promotion of ideals of peace among the peoples of the world.

Since wars began in the minds of men, it is in the minds of men that the defences of peace must be constructed.

The goals of UNESCO include:

- promoting Education for international understanding;
- promoting Sustainable Development based upon observance of human rights, mutual respect and the alleviation of poverty;
- contributing to the establishment of Cultural Identity and the promotion of culture directly;
- building co-operation and promoting exchanges among its Member States in the fields of education, the sciences, culture, communication and information.





# 2. The Jamaica National Commission for UNESCO

Almost all (201) Member States have established a National Commission for UNESCO. The UNESCO National Commissions are national cooperating bodies set up by the Member States for the purpose of associating their governmental and non-governmental bodies with the work of the Organization. Jamaica established its National Commission in November 1965

National Commissions are considered the mobilisers and catalysts for UNESCO's activities: they advise their governments on UNESCO affairs and work with the intellectual communities in the preparation, implementation and evaluation of UNESCO's programmes. National Commissions publicise UNESCO's mission and achievements, and are the channel through which the needs and aspirations of Member States are transmitted to UNESCO.

# 3. Activities in UNESCO's Programme Areas

#### 3.1. Education

#### Junior Debate International

The Junior Debate International series of debate culminated in June 2015. JNC-UNESCO assisted this exercise once again with the provision of certificates to approximately 200 participants.

This debate is hostted by Mr Campbell of the Police Commissioner's Office and is geared towards the Primary/Prep school age group.

#### **3.2.** Natural Sciences

- Science and Technology
- Environment

- Small Island Developing States (SIDS)

#### International Conferences

27-28 April 2015: UNESCO's Sub-regional Micro-science workshop was held in Guyana and our representative was Sadpha Bennett, Science Education Specialist. He said that it facilitated hands-on experiences in the use of the microscience kits to conduct specific practical exercises. It affirmed the objectives of the UNESCO micro-science Project which include:

- · allowing students to do practical work
- $\cdot$  encouraging enquiry while
- · attracting more students towards science careers

The Microscience Experiment is a hands-on science education project that gives primary,

secondary and tertiary students the opportunity to conduct practical work in physics, chemistry and biology, using small kits that come with pedagogical materials.

#### Addressing the Gap of Gender based violence

The main focus of this UNESCO Participation Programme project was on sensitization around gender-based violence with special emphasis on Trafficking in Persons and Sexual Harassment. Although several initiatives have been implemented to address gender-based violence against women and girls in Jamaica, gender-based violence in general and sexual violence against women and girls in particular continue to be a challenge.

The outputs from the project were:

- 1. **222 civil servants** sensitized on the draft National Sexual Harassment Policy and trained on how to develop a Sexual Harassment workplace policy. Sensitization was also provided on covered international conventions and treaties regarding women's rights and gender-based violence
- 2. **1,312 Community Leaders (Women and Girls)** sensitized on the Gender-based violence with emphasis on Trafficking in Persons
- 3. **173 members of the Justice System sensitized** on Gender-based violence with emphasis on Trafficking in Persons
- 4. **6** brochures on gender-based violence printed and being disseminated. The types of gender-based violence covered are:
  - 1. Sexual harassment in the workplace
  - 2. Sexual harassment in educational institutions

- 3. Domestic violence
- 4. Rape
- 5. Incest
- 6. Trafficking in persons

#### Bioethics

#### International Conferences

— 10-11 September 2015: The 2<sup>nd</sup> Regional Meeting of NBCs of the LAC Region was organized by the Latin America and the Caribbean Programme for Bioethics of UNESCO and the National Bioethics Committee of El Salvador was held in San Salvador (El Salvador). Participants were coordinators of existing Bioethics Committees as well as those in the process of creation. The Chairperson of the National Bioethics Committee of Jamaica, Dr. Tunde Bewaji, was our representative.

The aim was to consolidate a common space for identification of the main needs and difficulties of already existent CNBs and seek opportunities for mutual cooperation within the framework of the Latin American and the Caribbean Network of CNBs created in 2013.

UNESCO will contribute to this task through the promotion of CNB meetings and the provision of information and technical assistance thought its Assistance to Bioethics Committees Programme to those who require.

- 2 October 2015: Cheryl Brown was elected as Vice Chair (2016-17) of the the International Bioethics Committee (IBC) at the twenty-second Session of the IBC and Ninth Session of the World Commission on the Ethics of Scientific Knowledge and Technology (COMEST) meeting. It is the very first time the Caribbean was elected in the 22 years of the IBC. She is an Attorney-at-Law and was a Member of the National Bioethics Committee of Jamaica and Former Vice-Chairperson, Intergovernmental Bioethics Committee of UNESCO (IGBC).
- 16 to 18 March 2016: 11th Global Summit of National Ethics/Bioethics
   Committees had nearly 200 representatives from National Ethics Councils, National
   Bioethics Committees and members of international organizations (WHO and
   UNESCO etc) at its meeting in Berlin/Germany. Prof. Dr. John Bewaji, Chair of the

National Bioethics Committee of Jamaica, and Steering Committee Member for the WHO Region of the Americas, was in attendance.

The Global Summit is the only international meeting of National Ethics and Bioethics Committees for dialogue and exchange on bioethical questions as well as issues in the life sciences. The objectives of the Summit are to identify ethical issues of global concern, to provide a forum for exchange and to offer opportunities to discuss public health policies and research activities at international and regional levels.

#### 3.4. Culture

#### International Conferences

— 1-3 June 2015: UNESCO held a workshop on Developing a Follow-up Mechanism for Capacity-building Activities related to the 2003 Convention for the Safeguarding of the Intangible Cultural Heritage in Paris

UNESCO's Secretariat for the Safeguarding of the Intangible Cultural Heritage had identified that there exists a paucity of information on the progress made after UNESCO-funded capacity building workshops have concluded and has, further, identified that it needs to develop a follow-up and evaluation matrix to extract additional data to properly gauge the impact of the workshops and to see if there are any additional needs that the workshops could speak to.

Accordingly, UNESCO invited a group of 30 Experts, including Facilitators for the 2003 Convention, to discuss the need to provide this additional information and to formulate more effective delivery and reporting mechanisms on these workshops. The Senior Research Fellow of the African Caribbean Institute of Jamaica/Jamaica Memory Bank, David Brown, was invited in his capacity as a Facilitator for the 2003 Convention (1 of only 79 worldwide and 1 of only 3 from the region).

#### Conferences and Workshops in Jamaica

JNC-UNESCO held two World Heritage Workshops '*Youth Leadership Training in Heritage Preservation and Protection*' to create an awareness of World Heritage in Jamaica and to build capacity among its young people from the different parishes. The project took place against the background of the country lobbying for the Blue & John Crow Mountains to be listed as a UNESCO Heritage site

25-27 April 2015: The Kingston workshop was held at the Knutsford Court and catered to 44 participants from the parishes of Manchester, Clarendon, St. Catherine, Kingston & St. Andrew, St. Thomas, Portland and St. Mary. The participants visited the Blue and John Crow Mountains and Port Royal.

15-17 April 2015: The Montego Bay workshop was held at the Wexford Hotel. The 34 participants were mobilized from St Elizabeth, Westmoreland, Hanover, St James, Trelawny and St Ann including two overseas participants viz:

· Ralph Cantave, Youth rep., St. Maarten

· Rashel Hawker, Youth rep., Curacao ICH Committee

For this leg the participants visited the Seville Heritage site and undertook a Heritage Walk through Falmouth led by a knowledgeable Oshane Robinson.

Hon Minister Lisa Hanna, who handed out certificates of participation in Kingston, said that she was pleased that UNESCO had sponsored this training for the youths. She told the group " you are an exclusive group of young people who can make use of this opportunity in heritage training and know what is in Jamaica's best interest in having a heritage site and so move Jamaica forward as the cultural superpower it is".

5-9 October 2015: Phase 3 of the Project was initiated in Havana, Cuba. Jamila Pinto and Keitho Nembhard, the Chairman of the JNC-UNESCO Youth Advisory Committee, were the participants.

The Havana leg was in tangent with the two previous phases as it raised awareness of the importance of the sustainability of Heritage, especially since Cuba has the most World Heritage Sites (all of 9) in the Caribbean.

During the visit, they got a chance to visit the Revolution Square, Old Havana and the Fortifications as well as meet with Alicia Gonzalez Gutierrez, Permanent Secretary for the Cuban National Commission and Sandra Varela Labarrere, Assistant to the Director of the Regional Office of Culture for Latin America and the Caribbean (Mr Herman van Hoof).

From this visit to Cuba, Jamila Pinto, in the capacity as the Humanities and Education Rep, have decided to do a similar programme in the faculty as well as partner with JNC-UNESCO on this task for Youth Month in November. (Jamila Pinto)

#### Memory of the World (MOW)

#### International Conferences

9 October 2015: MOW International Advisory Committee inscribed 47 new nominations on the UNESCO Memory of the World Register. One of the 47 nominations included The West India Committee collection submitted on behalf of Antigua and Barbuda, Jamaica, UK, Anguilla and Montserrat

#### Conferences and Workshops in Jamaica

24 – 27 August 2015: The UNESCO Memory of the World Training Workshop for Latin America and the Caribbean was held in Kingston. The workshop was organized by the Korean National Commission for UNESCO and the Cultural Heritage Administration of Korea in cooperation with the UNESCO Kingston Office and the Jamaica National Commission for UNESCO.

The primary purpose of the workshop is to develop an increase in the identification and preservation of documentary heritage with global significance in Latin America and the Caribbean.

Participants came from the British Virgin Islands, Curacao, Dominica, Dominican Republic, El

Salvador, Haiti, Jamaica, Panama, Paraguay, St. Kitts and Nevis, St. Maarten, and St. Vincent and the Grenadines.

The workshop was opened by the Hon. Lisa Hanna, Minister of Youth and Culture who spoke to the significance of the Memory of the World programme. "As policy makers we need to anchor these things that make our country move and preserve our history. More training needs to be involved in protecting our intangible heritage in order to protect the information and create posterity", she stated.

# 3.6. YOUTH

International Conferences

— 18 - 29 June 2015: The World Heritage Young Expert Forum was held in Koblenz and Bonn, Germany under the theme "Towards a Sustainable Management of World Heritage Sites". The Forum is part of the World Heritage Education Programme of the UNESCO World Heritage Centre and is financed by the Federal Foreign Office of Germany.

The aims of the presentations are: – to give an impression of a world heritage site in your country. – to exchange different practices of sustainable management of World Heritage sites around the globe in a flash light.


#### Conferences/Workshops in Jamaica

The Jamaica Federation of UNESCO Clubs Centres and Associations (JFUCCA) seek to engage students in high schools and universities to participate in UNESCO related activities through the formation of UNESCO clubs. The challenge is in maintaining the level of interest and engagement as participating students graduate and move on to different institutions. Currently the three most outstanding clubs are: St Andrew High School for Girls, Holy Trinity High and the Kingston YWCA School Leaver's Institute.

St. Andrew High School for Girls UNESCO Club has been active for 10 years. This particular club include students who have an interest in science. Therefore, students are engaged in science related activities such as experiments, debates, gardening, volunteerism and the use of recycle materials for Art & Craft. Visits to a children's Home within the community form part of their voluntary activities.

Holy Trinity High School UNESCO Club activities are centred around fostering freedom of expression and Culture. The Celebration of International Days, research and visit of cultural sites are the main features of this club. Two club members Odetta Bundy and Clorian Cohen competed in the Caribbean Child Research Conference in 2015. These students submitted research papers entitled "An investigation on the Causes and Effect of Pollution on Children Living in the Community of Breaton" and "The Effects of Absentee Fathers" they were placed fourth and fifth respectively in the child researcher award category.



The Kingston YWCA School Leaver's Institute UNESCO Club priority areas of focus are Education and Culture. These focus areas were chosen in order to enhance and compliment the educational experience of these students who are mostly slow learners. Emphasis is also placed on activities that unearth talents and skills. The students have organized a dance group that has performed at specific school functions.

The club is also registered with Recycling Partners of Jamaica. Plastic bottles are collected for recycling purposes. Additionally, specific International Days are also celebrated with presentations from students and guest speakers and various symbolic gestures. On November 25, 2015 the YWCA UNESCO Club, observed the International Day for the Elimination of Violence against Women

# 4. External Relations

#### World Heritage

28 June - 8 July 2015 : Hon Lisa Hanna led a delegation, including Secretary General Everton Hannam to the 39<sup>th</sup> session of the UNESCO World Heritage Committee. On 3 July 2015 the renowned Blue and John Crow Mountains was inscribed to UNESCO's Prestigious World Heritage List. The inscription represents the first World Heritage site for Jamaica and the first mixed (cultural and natural) site for the Caribbean sub-region. It is one of only 32 mixed sites.

Addressing the World Heritage Committee following the unanimous decision, Minister of Youth and Culture, the Hon. Lisa Hanna, expressed gratitude to the World Heritage Committee for recognizing the extraordinary natural and cultural values of the Blue and John Crow Mountains. According to Minister Hanna, "This has been quite a journey for us as a country. The experience has taught us many things, and among them, we have learnt to appreciate our distinctive natural and cultural heritage even more.

The WHC members noted that the site is a further example on how different UNESCO conventions can exist together, recognizing that the intangible heritage of the Moore Town Maroons, which is one of the maroon communities in the Blue and John Crow Mountains, was inscribed on the Intangible World Heritage List in 2009.

Also addressing the World Heritage Committee was Colonel of the Moore Town Maroons, Wallace Sterling who dedicated the prestigious listing to the maroons of Jamaica, "We know our ancestors are looking down on this moment, very proud that this universal prestige is being given to us, in part because they were selfless, committed, strong, cunning and resourceful persons who found ingenious ways to dismantle a system that blighted peoples of the region. Their efforts to put an end to one of the darkest periods of our history are what we acknowledge and celebrate as Maroons today. Importantly, we hail the legacy passed on to us by our ancestors - they have helped to shape our identity of self, and community".

The Ministry of Youth and Culture and its agencies worked vigorously since 2013 by lobbying for a prestigious space as one of 21 countries to sit on the World Heritage Committee.

30 October 2015: The official launch of the UNESCO World Heritage Site of the Blue & John Crow Mountains was held in Jamaica at Moore Town, Portland.

11 December 2015: Kingston was designated a Music City in the UNESCO Creative Cities Network. Being the economic, social and cultural center of creation, Kingston has given the world 6 distinct musical genres: mento, ska, reggae, rocksteady, dub and dancehall. With music and cultural activities at its core, Kingston boasts numerous theatres, a National Dance Theatre Company, a National Gallery, a craft market, the region's only Visual and Performing Arts College, the island's most important TV and radio stations, numerous sound systems, recording studios and music venues.

#### CELAC

17-21 September 2015: Secretary General Everton Hannam represented Minister Lisa Hanna at the 3rd Meeting of Ministers of Culture of the Community of Latin American and Caribbean States (CELAC), Cuba. UNESCO's Director General, Irina Bokova also participated in this meeting.

The Meeting was preceded by the UNESCO Workshop for the adoption of a Work Plan for Culture for Latin America and the Caribbean 2016-2021, which will focus on articulating a cultural action plan as defined in two previous meetings held in Suriname (2013) and Venezuela (2014).

Within this plan are issues such as the defense and conservation of tangible and intangible heritage, the prevention and fight against the illegal trafficking of cultural goods, social and cultural development, diversity of cultural expression and the strengthening of artistic exchanges, among others.

In its final declaration the CELAC Ministers of Culture welcomed the initiative of this UNESCO work plan and encouraged its enrichment through participatory work with the countries of CELAC. They also celebrated the 70th anniversary of UNESCO and the 10th anniversary of the *Convention on the protection & promotion of the diversity of cultural expressions,* a legal instrument of high relevance to the region.

#### 50th Anniversary Celebration

November 2015: The Jamaica National Commission for UNESCO celebrated 50 years which according to UNESCO's Director General, Irena Bokova, was "50 years of leadership and action".

We have had the issuance of a 50th Anniversary supplement, a Church Service, launch of the exhibition and lecture series, exhibitions at various JLS libraries (Kingston & St Andrew

Parish Library, Manchester Parish Library).

At the Church service Dr. Donald Rhodd, Vice Chair of JNC-UNESCO, delivered the anniversary message at the Shiloh Apostolic Church in Port Antonio, Portland. The choice of worshipping in Portland for the 50<sup>th</sup> Anniversary was made because this parish, along with St Thomas and St Andrew, now boasts the distinction of being the home to Jamaica's first UNESCO World Heritage site – the Blue and John Crown Mountains.

#### Korean Nation Commission Colloboration

27-29 August 2015: The Korean National Commission (KNCU) and the Jamaica National Commission for UNESCO (JNCU) co-organized the website development Training Workshop following a successful collaboration in 2014, resulting from the 2013 MOU between the two National Commissions.

During the Development Training workshop which took place at the Jamaica Pegasus, website managers from each of the participating National Commissions received hands-on training and expert advice that equipped them with the necessary skills to manage and operate their new websites.

Three National Commissions in the Caribbean and Central America region were selected for the 2015 Web Development Project: the Dominican Republic, Costa Rica and Trinidad and Tobago National Commissions. These three female participants were joined by two male Jamaican youth participants from the Ministry of Youth and Culture.

KNCU hopes that the project will increase the capacities of the three participating National Commissions and that the newly created websites will successfully promote cooperation and knowledge sharing among National Commissions

- CARICOM Reception date/format. Not many Member States contributed to this effort. Jamaica however supported the activity as it was used to celebrate our 50<sup>th</sup> Anniversary.

• Outlined the way forward to strengthen UNESCO's work in the Caribbean toward achieving the Sustainable Development Goals and anchoring Small Islands Developing States (SIDS) priorities in the Post-2015 Development Agenda; Enhanced partnerships and networking among the Caribbean National Commissions between themselves and with the UNESCO Cluster Office for the Caribbean be strengthened with other as well as actors such as the academy; • Facilitated that the Caribbean National Commissions for UNESCO be better prepared to attend and contribute to the work of the upcoming 38th General Conference;
