1. UNESCO

1.1. Introduction

The United Nations Educational, Scientific and Cultural Organization (UNESCO) was founded on 16th November 1945 and is headquartered in Paris, France. The Preamble of the UNESCO Constitution establishes UNESCO as an organisation committed to the promotion of ideals of peace among the peoples of the world.

Since wars began in the minds of men, it is in the minds of men that the defences of peace must be constructed.

The goals of UNESCO include:

- promoting Education for international understanding;
- promoting Sustainable Development based upon observance of human rights, mutual respect and the alleviation of poverty;
- contributing to the establishment of Cultural Identity and the promotion of culture directly;
- building co-operation and promoting exchanges among its Member States in the fields of education, the sciences, culture, communication and information.



2.3.2. The Secretariat

The Secretariat is responsible to the Commission for the effective implementation and coordination of the programmes and activities of UNESCO in Jamaica, and for advising on and implementing policy decisions.

The Secretariat prepares and administers the annual budget of expenditure; prepares briefs on the various areas to be covered at the General Conferences of UNESCO; monitors projects; and ensures that reports and invoices are sent to UNESCO at the completion of each project.

3. Activities in UNESCO's Programme Areas

3.1. Education

Conferences and Workshops in Jamaica

In response to the growing concerns of student's performance, the Jamaica Teaching Council designed a UNESCO Participation Programme Project to look at how to improve the proficiency of the students in these areas. Project Director Dr. Winsome Gordon in defining the scope of the project wrote the following:

"The standards "Proposed Professional Standards for Teachers of Mathematics and English in Secondary Schools" represent the working groups' vision of what should characterize the practice of teaching for students to acquire mathematical and language proficiency, and for improvements in students' performance in the Caribbean Secondary Education Certificate (CSEC) examination.

Not only do standards guide performance but they also stimulate action, promoting efforts at and successes in achieving levels of excellence. The first section of these standards summarizes the background to the standards; the second section presents the standards themselves and performance indicators associated with them."

Junior Debate International

JNC-UNESCO along with other sponsors funded the Junior Debate International which took place on 15 June 2012 at the Police Officers' Club in Kingston. Thirty four schools entered the debate. In the finals were Lannamans Preparatory from St. Andrew and Mt. Alvernia Preparatory from the Parish of St. James who, after a keenly contested debate, was adjudged the winner.

The schools debated the moot, "Education is the key to success." to a packed audience headed by the Chief Justice of Jamaica Honourable Zaila McCalla and two bench colleagues Justice Paulette Williams and Justice Marathi together with Jamaica National Commission for UNESCO representative, Doolarie Hopkinson and Conference Chairman Dr. Jossette Smikle, UWI.

Secretary-General Everton Hannam attended the "24th session of ICC-MAB Council Meeting" held 9-13 July 2012 in UNESCO, Paris.

— The "Inter-Ministerial and Experts Conference on Biosphere Reserves in the Caribbean Sub-Region: Tools for Sustainable Development and Growth" was organized by the Government of St. Kitts & Nevis and the MAB Programme. It was held 26-27 March 2013 in St Kitts.

During the conference an action plan for the next three years was established with the aim to create a network of biosphere reserves in the Caribbean Small Islands States.

Currently St. Kitts and Nevis has the first Biosphere Reserve in English-speaking Region and Jamaica has a submission to be tabled at the 25th Session of the International Co-ordinating Council (ICC) of the Man and the Biosphere (MAB) Programme UNESCO Headquarters to be held 27 - 30 May 2013.

Haiti's La Selle region was among 20 sites recently added to UNESCO's World Network of Biosphere Reserves. It is Haiti's first biosphere reserve and is now part of a list that includes 598 reserves in 117 countries.

The St. Kitts & Nevis Declaration was also agreed upon by all ministers, UNESCO representatives and experts to that effect, including empowering UNESCO to identify

and secure extra-budgetary funds to facilitate the Caribbean island states to execute the action plan.

Jamaica was representated by the Hon. Ian Hayles, Lt Oral Khan (Chief Technical Director, Ministry of Climate Change) and Secretary-General Everton Hannam.

The 19th (Ordinary) Session of the International Bioethics Committee (IBC) was held at UNESCO Headquarters in Paris from 10 to 14 September 2012. In conjunction with this session, the Joint Session of the IBC and the Intergovernmental Bioethics Committee (IGBC) was also held on 13 and 14 September 2012. Both sessions brought together 151 participants from 74 countries.

Conferences and Workshops in Jamaica

The NBCJ held two activities from 18-19 February 2013 at the University of the West Indies

to focus on issues relating to the protection and use of health information in Jamaica.

The first was a seminar **"Beyond the common law protection of confidences in health care"** which was addressed by four experts in issues related to the legal and ethical aspects of privacy and confidentiality of health information., The experts were: Dr. Derrick Aarons, Jamaica; Dr. Kenneth W. Goodman, USA; Carol Appathurai, Canada and Dr. Mark Taylor, UK; The overseas experts were also part of the second activity **"Health information use & protection: consultation meeting"** Along with stakeholders they sought

- To identify what information should be classified as health information
- To determine the role technology may / does play in the generation, transmission, storage and disposal of such health information in Jamaica
- To examine the legislative measures in place in selected countries; specifically, the United Kingdom, Canada and the United States.

The outcome was to form Working Parties, with the power to co-opt, to examine ethical and legal issues as identified at this meeting, pertaining to the protection of health information in Jamaica. The working parties will be responsible for collecting and summarizing information to develop draft position papers, reporting back at the 2nd and subsequent Consultations.

An exhibition showcasing information on Bioethics was displayed on both days.

3.4. Culture

International Conferences

 Jasinth Simpson of JNHT attended the "Caribbean Training Course in the Preparation of Nomination Dossiers for World Heritage" held 24 to 28 March 2013 in St. Mary's, Antigua & Barbuda.

The UNESCO World Heritage Centre in Paris, the UNESCO Offices in Kingston and Havana in collaboration with the Antigua & Barbuda National Commission for UNESCO organized this training exercise designed within the framework of the Japanese Funds-in-Trust project "Capacity Building to Support the Conservation of World Heritage Sites and Enhance Sustainable Development of Local Communities in Small Island Developing States (SIDS)".

The training course, a follow-up to the June 2012 training held in Kingston, Jamaica, brought together some 20 representatives from Antigua and Barbuda, Barbados, Belize, British Virgin Islands, Dominica, Grenada, Guyana, Jamaica, St. Kitts and Nevis, St. Lucia, St. Maarten, St. Vincent and the Grenadines, Suriname, The Bahamas, and Trinidad and Tobago.

— Debra Kay Palmer (JNHT) and Dr. Maria Smith (JNC-UNESCO) attended the workshop "Management of Caribbean cultural resources in a natural environment: Sites of Memory and participation of local communities" held near the Historic Bridgetown and its Garrison, World Heritage site in Barbados, from 11 to 15 March 2013.

The workshop is part of a series organized by UNESCO Offices in Havana and Kingston and UNESCO's World Heritage Centre, with the support of the Netherlands Funds in Trust and delivered in coordination with the Barbados National Commission for UNESCO and The University of the West Indies (UWI), Cave Hill Campus.

The workshop trained 20 participants from Barbados, Curaçao, Grenada, Jamaica and Saint Vincent and the Grenadines to foster the best involvement of local communities in World Heritage and implemented also an agreement reached in June 2011 on the Caribbean Capacity Building Programme (CCBP) for World Heritage between the University of the West Indies and UNESCO.

— Langley Robinson of the Jamaica Customs Department attended UNESCO's "Subregional Capacity Building Workshop to enable Caribbean Member States to effectively fight illicit trafficking in Cultural Property". This workshop was hosted by the Saint Lucia National Commission for UNESCO from 3-5 December 2012 in Castries, St. Lucia.

Participants came from 14 UNESCO member states: Antigua and Barbuda, Bahamas, Barbados, Belize, Dominica, Grenada, Guyana, Jamaica, Saint Kitts and Nevis, St Maarten, Saint Vincent and the Grenadines, Surinam and Saint Lucia.

The presenters drawn from UNESCO and several of its international partners such as INTERPOL and World Customs Organizations sought to enlighten the participants about the trafficking problem in the region. They discussed areas as mechanisms of control and the role and legal aspects of the Customs Service, strengthening of national, legal and operational capacities to assist in this fight to protect a country's national heritage. *To celebrate Jamaica50 the UNESCO Kingston Cluster Office for the Caribbean and JNC-UNESCO organized the following two activities.*

— Jamaica hosted the "Caribbean Training in the Preparation of Nomination Dossiers for World Heritage: Capacity Building to support the Conservation of World Heritage Sites", from 5-15 June 2012 in Kingston. The Japan Funds-in-Trust provided USD 338,000 to this training programme as part of a project for sustainable development of local communities in small island developing states (SIDS).

The training course brought together 20 Caribbean experts representing Antigua and Barbuda, Barbados, Belize, Cayman Islands, Curacao Dominica, Grenada, Guyana, Jamaica, St. Kitts and Nevis, St. Lucia, St. Maarten St. Vincent and the Grenadines, Suriname, The Bahamas, and Trinidad and Tobago alongside two Caribbean experts as facilitators from Cuba and Jamaica, and six guest speakers from Barbados, Curacao and Jamaica.

The training ended with the adoption of the action plan in preparation of the followup training scheduled for March 2013 to assess the

preparation of the nomination dossiers.

At the Opening the Hon. Minister Lisa Hanna gave the feature address and thanked the Japanese government for the financial support which was seen as timely and valuable so that the people of the Caribbean can identify from whence they came and show the world their value and wealth.

Remarks were given by the Japanese Ambassador His Excellency Hiroshi Yamaguchi who spoke on the cooperation between Japan and UNESCO.

A highlight of the Opening was the launch of the poster featuring the eight English & Dutch speaking Caribbean World Heritage sites.

"UNESCO Award of Excellence for Handicrafts in the English & Dutch speaking Caribbean" followed the April 2011 Bahamas Consultative meeting which agreed upon a strategy for the implementation of the Award programme in the Caribbean

At the national level exhibits were selected in the participating country and forwarded for regional judging in Jamaica. At the regional level 9 countries participated. In Jamaica, with support from CHASE FUND, the

"UNESCO Award of excellence for handicrafts in the



English & Dutch speaking Caribbean" commenced with national judging which saw 10 entries being entered for the regional judging.

Six (6) entries were given the Award of Excellence for Handicrafts in recognition of high standards, innovation, high quality and authenticity. They were chosen from a

field of 34 items by three (3) International Jurors. Two (2) Jamaican items were among the six awardees.

Conferences and Workshops in Jamaica

Jamaica hosted a national workshop on the implementation of the 2003 Convention for the Safeguarding of Intangible Cultural Heritage from 10-14 December 2012.

This workshop was organized by The African Caribbean Institute of Jamaica / Jamaica Memory Bank, the Jamaican National Commission for UNESCO and the UNESCO Kingston Cluster Office for the Caribbean, and brought together government officials, non-governmental organizations and community practitioners to partake in the workshop on the implementation of the 2003 Convention for the Safeguarding of Intangible Cultural Heritage. Practitioners who participated in the workshop included members of the Maroon, Rastafari

and Revival communities.

The workshop concluded with a Kingston Action Plan for ICH proposing continued work in the following areas: Awareness raising; Community participation; Inventorying; Planning and communication among stakeholders; Cultural policy; Regional and International Cooperation.

This workshop series is part of a sub-regional project being implemented in Belize, Jamaica and Trinidad and Tobago within the context of UNESCO's Global Strategy on capacity building on intangible cultural heritage.



3.7. Youth

International Conferences

Romaine Butler (The Mico University) and Kemesha Kelly (a former Youth Empowerment Officer) were selected from Jamaica to attend the "**Caribbean Youth Forum on Intangible Cultural Heritage"** that was held in St Georges, Grenada, 20-24 November, 2012. They were among 25 participants from 17 different Caribbean states.

The Forum aimed to recognise the significant role of young people in safeguarding intangible cultural heritage and the need to strengthen their knowledge and capacities in this area. They learnt about the core concepts of the Convention, developed substantial understanding of its mechanisms and their role in the safeguarding of intangible cultural heritage.

Youth Poverty Alleviation through Tourism and Heritage Training

Youths from in and around the environs of Sligoville received YouthPATH (Youth Poverty Alleviation through Tourism and Heritage) training as part of efforts by the Jamaica National Commission to empower youth and raise heritage awareness in Jamaica. This training is one part of a 3 component project "Engaging Young People through Training in Support of Sustainable Development" and was associated with Jamaica's first free village, Sligoville, in Guys Hill, St. Catherine.

They were selected by the JNC-UNESCO in collaboration with the Member of Parliament for the area, Hon. Minister Natalie Neita-Headley. From 11 November to 7 December 2012, they received the training in a variety of skills that can be used in the heritage tourism industry:

- o Sensitization/Orientation
- Natural and Cultural Heritage Workshop
- CPR and First Aid Training
- Team Jamaica and Tour Guide Training

At the closing ceremony at the Courtleigh Hotel in Kingston Hon. Minister Natalie Neita-Headley presented participants with certificates. Of the twenty, nineteen were successful in their tour guide assessment and were certified while all ten were successful in both the CPR and First Aid activities.
