# 1. UNESCO

## 1.1. Introduction

The United Nations Educational, Scientific and Cultural Organization (UNESCO) was founded on 16<sup>th</sup> November 1945 and is headquartered in Paris, France. The Preamble of the UNESCO Constitution establishes UNESCO as an organisation committed to the promotion of ideals of peace among the peoples of the world.

Since wars began in the minds of men, it is in the minds of men that the defences of peace must be constructed.

The goals of UNESCO include:

- promoting Education for international understanding;
- promoting Sustainable Development based upon observance of human rights, mutual respect and the alleviation of poverty;
- contributing to the establishment of Cultural Identity and the promotion of culture directly;
- building co-operation and promoting exchanges among its Member States in the fields of education, the sciences, culture, communication and information.





# 2. The Jamaica National Commission for UNESCO

Almost all Member States have established a National Commission for UNESCO. The UNESCO National Commissions are national cooperating bodies set up by the Member States for the purpose of associating their governmental and non-governmental bodies with the work of the Organization. Jamaica established its National Commission in November 1965

National Commissions are considered the mobilisers and catalysts for UNESCO's activities: they advise their governments on UNESCO affairs and work with the intellectual communities in the preparation, implementation and evaluation of UNESCO's programmes. National Commissions publicise UNESCO's mission and achievements, and are the channel through which the needs and aspirations of Member States are transmitted to UNESCO.

## 2.3. The Secretariat

- contribute to the creation of a climate favourable to the development of the areas of UNESCO's competence

#### 2.3.2. The Secretariat

The secretariat is responsible to the Commission for the effective implementation and coordination of the programmes and activities of UNESCO in Jamaica, and for advising on and implementing policy decisions.

The secretariat prepares and administers the annual budget of expenditure; prepares briefs on the various areas to be covered at the General Conferences of UNESCO; monitors projects; and ensures that reports and invoices are sent to UNESCO at the completion of each project.

# **3.** Activities in UNESCO's Programme Areas

## 3.1. Education

#### International Conferences

 To celebrate the 60th Anniversary of the UNESCO Associated Schools Project Network (ASPnet), an International Forum was organized in the Republic of Korea. It assessed the ASPnet's key achievements and its management over the past decade on the school, national, regional and international level as well as the implementation at the country level. It further discussed emerging challenges and defined recommendations for a new Draft Strategy 2014-2021 for the Network.

ASPnet representatives – National Coordinators, teachers and students – from the 180 ASPnet Member States came together to highlight ASPnet's continued importance in supporting UNESCO priorities and to contribute to the promotion of Global Citizenship. Jamaica was represented by Secretary General, Everton Hannam (see picture below).



 The Regional Bureau of Education for Latin America and the Caribbean (OREALC/UNESCO Santiago) provided support for a sub-regional consultation meeting. It was organised in cooperation with the Jamaica National Commission for UNESCO and supported by UNEP from 3-4 April 2013 at the Knutsford Court in Kingston.



Its aim was to make advances in the preparation of the final monitoring and evaluation report of the UN Decade of Education for Sustainable Development (2005-2014). The meeting contributed to the creation of a new global framework defining follow-up activities for the decade, and added to preparations being made for the world conference held in Japan in 2014.

11 countries participated including Jamaica who had 15 participants thus allowing for input from relevant stakeholders in Latin America and the Caribbean.

#### Conferences and Workshops in Jamaica

#### Junior Debate International

The Junior Debate International series of debate culminated on 20 June 2014. JNC-UNESCO assisted this exercise with the provision of certificates to aproximately 200 participants.

#### International Literacy Day/Exhibition

International Literacy Day is celebrated annually on 8 September but in Jamaica in 2013 it was celebrated on Friday 6 September. On that day all MOE regions launched International Literacy Day at a parish library. At the Region 5 Manchester Parish Library Keitho Nembhard, NATCOM member, read the Director's Speech.

In Region 2, there was an activity hosted in conjunction with MOE, Region 2. There JNC-UNESCO exhibited on UNESCO-Education/Literacy

## International Conferences

The UNESCO/UWI/SOE Education for Sustainable Development /Climate Change Education for Sustainable Development Workshop was held at the Mona Visitors' Lodge and Conference Centre, the University of the West Indies from 15-17 May 2013. It was attended by thirty-two local and regional participants including teachers, Heads of Department, Vice-Principals, Deans. and representatives of various educational institutions in the region. The keynote presenters were Dr. Michael Taylor (HOD, Department of Physics and Chair, Climate Change Studies) and Professor Rosalyn McKeown, UNITWIN/UNESCO Secretariat and Chair in Reorienting Teacher Education to Address Sustainability, York University.

Chairing the Opening Ceremony was Prof. Stafford Griffith, Director of the School of Education. He welcomed all the participants in particular those from other islands. He thanked UNESCO for being largely responsible for funding the workshop. He also spoke about the reality of climate change and of education as an essential element of the response to it. He then outlined the objectives of the workshop and concluded with SOE's commitment to mainstream ESD in teacher education curricula.

Representing the Dean of the Faculty, Dr. Swithin Wilmot, Prof. Sylvia Kouwenberg spoke to the question of the concept of 'development'. She went on to acknowledge the importance of the workshop in exploring ways CCESD could be integrated in the curricula at different levels of the education system. She also remarked on the importance of a regional network for ESD.

Mr. Everton Hannam emphasized the need for education at all levels in order to change the way we think and act for sustainability. He pointed out too the importance of their being a decade dedicated to ESD and its importance for a region as vulnerable as the Caribbean. He also spoke to the need for sustainable livelihoods in order to have a sustainable future. He then outlined ways in which support from the Jamaica National Commission for UNESCO could be obtained.

Dr. Michael Taylor began his addressing by noting that CCESD has encouraged a crossing of boundaries with the Head of the Department of Physics addressing a workshop in the

Faculty of Humanities and Education. Situating his address in what he referred to as '3 embarrassingly simple insights': climate has changed, climate will change and climate demands change, Dr. Taylor spoke to present climate changes and the vulnerability of Caribbean people whose livelihoods are dependent on climate.

Man and the Biosphere (MAB) International Conferences

> — The **25<sup>th</sup> Session MAB-ICC** was held in Paris 27-30 May 2013. Participants included representatives of the following Members of the ICC as elected by the UNESCO General Conference at its 36th session: Austria, Bahrain, Belarus, Chile, Costa Rica, Côte d'Ivoire, Democratic Peoples Republic of Korea, Egypt, Estonia, Ethiopia, Ghana, Haiti, Honduras, Iran, Jamaica, Japan, Jordan, Kenya, Lebanon, Lithuania, Luxembourg, Mexico, Nigeria, Norway, Portugal, Republic of Korea, Tanzania, Thailand, Turkey, United Kingdom of Great Britain and Northern Ireland, Ukraine, and VietNam. In addition, observers from the following Member States were present: Albania, Belgium, Brazil, Cameroon, Canada, China, Colombia, Democratic Republic of the Congo, Djibouti, Ecuador, France, Germany, Greece, Guatemala, Guinea, Hungary, India, Indonesia, Italy, Iraq, Kazakhstan, Madagascar, Malaysia, Mongolia, Namibia, Niger, and, Saint Kitts and Nevis, Slovakia, Spain, South Africa, Sudan, Sweden, The former Yugoslav Republic of Macedonia, The Netherlands, Tunisia, Uganda, and Vanuatu. IUCN (International Union for Conservation of Nature), IUBS (International Union of Biological Sciences), SCOPE (Scientific Committee on Problems of Environment), RAMSAR Convention were also present.

This meeting was of particular interest since Jamaica had submitted "The Portland Bight", its first Biosphere nomination. The Council warmly welcomed the first biosphere reserve proposal from Jamaica to Secretary General, Everton Hannam, who represented Jamaica.

The Portland Bight lies in the centre of Jamaica's south coast, west of the capital, Kingston. It covers different island ecosystems, including three ranges of coastal hills, coastal plains and the coastal shelf extending to the drop off. The marine area contains mangroves, coral reefs, seagrass beds and wetland areas. The mangrove systems of West Harbour are particularly well preserved and extensive. There is also a freshwater marsh, one of Jamaica's rarest and most threatened types of ecosystems. This area also includes the Ramsar site of Portland Bight. The site also includes a high fishery production site for local fishermen in an area marked by poverty.

Following the advice of the Advisory Committee, the Council noted that the proposed site has only a marine core area and is not surrounded by a buffer or transition area. The Council encouraged the government to submit a new zonation system, including

terrestrial core area(s) which need(s) to be surrounded by buffer and transition areas.

The Council decided that this site be deferred and that new zonation system with the appropriate figures should be submitted. The Council again recommended the national authorities to seek advice from a member of the Advisory Committee.

#### The World Network of Island and Coastal Biosphere Reserves, 3rd meeting

Organized by the Man and the Biosphere Programme, the West-Estonian Archipelago biosphere reserve, Jeju Island biosphere reserve and Menorca biosphere reserve hosted the Third Meeting of the Global Network of Island and Coastal Biosphere Reserves . It took place in the Islands of Hiiumaa and Saaremaa.



The meeting brought together representatives of island and coastal biosphere reserves to discuss the main challenges and threats facing these areas - climate change; water, energy and food self-sufficiency; and waste management - and to share experiences and potential solutions.

The Global Network of Island and Coastal Biosphere Reserves was created at the 21st Session of the International Coordinating Council of the Man and the Biosphere Programme in 2009. This Network aims to realize the potential of biosphere reserves in addressing climate change, particularly as places for learning about sustainable development and also for experimenting on mitigation and adaptation measures on climate change.

This third meeting held in Estonia from 3-7 June 2013 was attended by Jamaica, Haiti and St. Kitts/Nevis who were invited for the first time and were part of the 17 countries in attendance. Secretary General, Everton Hannam was Jamaica's representative.

A recommendation arising out of this meeting is for Jamaica to move expeditiously and re-establish its MAB Committee.

## 3<sup>rd</sup> Training of NBCJ/ABC Project

Members gathered at the Knutsford Court Hotel in Kingston, May 20-22 for the 3 day training which was conducted by 3 UNESCO selected experts: Ms. Susanna Vidal, Chief of Section for Bioethics at the UNESCO Montevideo Office; Henk ten Have MD, PhD, Professor and Director of the Center for Healthcare Ethics at Duquesne University, USA, and former Director of UNESCO'S Division of Science and Technology; and Harald Schmidt PhD, Lecturer at the Department of Medical Ethics and Health Policy, Perlman School of Medicine, University of Pennsylvania, USA.

At the end of the training members expressed great satisfaction with and appreciation of the training. Time was taken during the last session of the training to focus on the way forward for the National Committee. After a spirited discussion, in which the current status of the committee was evaluated, it was concluded that the committee needed to adopt a more proactive approach. This would mean responding more readily to issues of national interest whilst cultivating an image free from bias to any particular sector/ group etc. in the society. It was decided to utilise a "think tank" approach to creating documents expressing views on issues of concern and work to get these views publicized. It was also agreed that additional effort was to be made to get involved in government policy development processes. Towards achieving this latter aim, the committee will seek the help of the Deputy Chairman for the National Commission with whom dialogue has commenced.

## International Conferences

Bahamas hosted The 2-day а conference focused on the handicraft sector on 1 and 2 July 2013 under the theme 'Strengthening the Cultural and Creative Potential of the Handicraft Sector within the English and Dutch speaking Caribbean.' Organized by the Bahamas National Commission for UNESCO and the Jamaica National Commission for UNESCO with technical assistance from the UNESCO Kingston Cluster Office for the Caribbean, the together brought workshop government officials, nongovernmental organizations, handicraft practitioners and creative entrepreneurs who are involved in

various ways in the handicraft sector. Delegations from Antigua and Barbuda, Belize, Curacao, Guyana, Jamaica and The Bahamas participated in the conference.

Dr. Leon Higgs, Secretary-General of The Bahamas National Commission for UNESCO extended warm welcome to participants and guests. Speaking at the official opening, the Prime Minister of The Bahamas, the Rt. Hon Perry G. Christie urged handicraft stakeholder to "Think Big" and also cited that the handicraft industry was "....*a US 300 million dollar per year industry in the Bahamas and which included spend on imported craft items*" and encouraged individuals to get serious about the industry. Other Ministers present at the opening included Hon. Dr, Daniel Johnson, Minister of Youth, Sports and Culture, Bahamas and Hon. V. Alfred Gray, Minister of Agriculture, Marine Resources and Local Government, Bahamas.

Also in attendance were Ms Marva Browne, Secretary-General of Curacao National Commission for UNESCO; Dr. Rudolph Anthony Jr., Secretary-General of Belize National Commission for UNESCO and Dr. Maria Smith, Programme Manager of Jamaica National Commission for UNESCO. Approximately 60 persons inclusive of participants, government officials and handicraft stakeholders were present at the opening. The Secretaries-General and National Commission representatives also used the opportunity to discuss strategies for the submission of the second round of the UNESCO Award of Excellence for Handicraft in the English and Dutch Speaking Caribbean slated for Curacao in 2014.

The 2-day workshop saw intense discussions about the handicraft sector in the sub-region with focussed deliberations on national policies specific to the handicraft sector, product design and development strategies, and recreating linkages locally, inter-regionally and globally. Participants also emphasized the need to maintaining the UNESCO Award of Excellence for Handicraft. The UNESCO Award of Excellence for Handicraft was launched in the Dutch- and Englishspeaking Caribbean in 2012 in Jamaica Prime Minister, Rt. Hon Perry G. Christie looks at the 2012 Award o with six out of 34 entries receiving the UNESCO Award of Excellence Handicrafts. The six craft items were


The workshop focus was on community participation in the identification and inventorying of intangible cultural heritage, data collection, organization and management, and hands-on experience in preparing field work. The workshop along with the field exercise will set the stage for a pilot inventory activity to follow in proceeding months.

Funded by the Government of Japan, the workshop is part of a sub-regional project being implemented in Belize, Jamaica and Trinidad and Tobago within the context of UNESCO's global strategy on capacity building to safeguard intangible cultural heritage. # 3.6. YOUTH

- The 8th UNESCO Youth Forum which preceded the General Conference was held

from October 29-31 at the UNESCO Headquarters in Paris, France.

Maurice Smith, a Prime Minister Youth Awardee and an active member of the Graduates Foundation of Jamaica was Jamaica's representative to this Youth Forum.

Over 500 young participants have called on Member States, coming to UNESCO for the 37th General Conference, to create autonomous structures in each country to encourage and support youth engagement from now until 2021. (UNESCO)

Increase the visibility of UNESCO among youth and increasing volunteers for UNESCO programme was held in 3 locations

Facilitated by the Jamaica National Commission for UNESCO the project was formulated by Paul McFarlene and Stefanie Thomas in an effort to help UNESCO have a more direct impact on the youth of Jamaica.

This PP project was designed as an island-wide train the trainers Programme with special emphasis in the following areas: sexuality and behavioral changes, environment and climate change, social media development.

Through this initiative workshops were conducted and young people from across the Island received training in the areas cited.

In a ceremony held on March 21, 2014 at the Knutsford Court Hotel, some 32 persons were presented with their certificate of competency having completed their training.

The certificates were presented by Minister of Youth and Culture Lisa Hanna, who is

also the chairperson for the Jamaica National Commission for UNESCO. The minister expressed her satisfaction with the execution of the programme and says she is pleased that young persons are taking advantage of the assistance being offered by UNESCO.

The Youth For UNESCO project targeted persons aged 15 to 25 years in schools, community based groups, churches, and youth clubs.
